FLOWER MART IS THE OLDEST FREE PUBLIC FESTIVAL IN THE CITY OF BALTIMORE, HAVING BEEN FOUNDED IN 1911. IT CELEBRATES SPRING DURING THE FIRST WEEKEND OF MAY WITH NEARLY 100 LOCAL VENDORS, MUSICIANS, AND PRESENTERS. MONUMENT LIGHTING IS OVER FIFTY YEARS OLD, AND IS CELEBRATED ON THE FIRST THURSDAY IN DECEMBER. IT INVOLVES LOCAL MUSIC AND FOOD VENDORS WITH A FINALE OF FIREWORKS. BOTH LARGE FESTIVALS INVOLVE COMPLICATED LOGISTICS, RENTALS, AND STAFFING TO PRESENT THEM FREE TO THE PUBLIC.
